25 **THE COURT MADE THE FOLLOWING RULINGS:**


- 26 1. The Application by Class Counsel for: (1) An Award of Attorneys' Fees and

28 2. Class Counsel are hereby awarded attorneys' fees in the amount of \$371,387.76,
payable from the settlement funds;

- 3. Class Counsel are hereby awarded reimbursed expenses in the amount of \$319,524.53, plus interest at the rate actually charged but not to exceed 10%, payable from the settlement funds; and,
- 4. Incentive award in the amount of \$1,000.00 is to be awarded to each of the 30 Mortuary Class Representatives; and, incentive ward in the amount of \$4,000.00 is to be awarded to each of the seven Cemetery Class Representatives; for a total of \$65,000.00 in incentive payments to the class representatives, payable from the settlement funds.
